Anna provided highlight examples in the of the four types of priorities FACCC uses to group ideas. She focused on 1705 response ideas to allow CCs to offer more classes. Student data from the state is not looking good for 1705 and the legislature in more receptive to making changes. Working to find author of our bill. Significant discussion on 1705.

Noted that a parallel AI-bill for non-instructional faculty is high priority for FACCC. She also noted that the outcome of the 50% audit is due out in the next few months and there may be an opportunity/need to support/oppose legislation resulting from the audit.
